




Tenacity & Transformation

For nearly three decades, Children’s Law Center has been building a strong foundation for DC children. Through individual and city-wide advocacy, we address the urgent **family, health and education** needs of children and families while creating lasting solutions to complex societal challenges. Families trust us because we are effective problem-solvers. City and community leaders turn to us as the experts who get results for DC kids.

In partnership with children and families, we use the law and navigate complex systems to address urgent problems impacting children today, improve the systems that will affect their lives tomorrow and strengthen our community so that change endures.

We also led the fight to create two new government agencies – one to monitor the wellbeing of children in the foster care system and a second focused on enforcing housing code violations that harm children’s health or risk their safety.

Three Decades of Impact & Innovation

1996

Founded Children’s Law Center to address the comprehensive needs of DC children.

2003

Expanded representation of children in abuse and neglect cases through contract with DC Superior Court.

2009

Improved outcomes for children through rigorous program evaluation.

2015

Instituted onsite presence in Wards 7 & 8 through growth of our medical-legal partnership.

2019

Secured first-in-nation contract with managed care organization to address housing conditions for children with asthma.

1997

Established pro bono program to leverage resources from major law firms.

2002

Launched medical-legal partnership with Children’s Hospital to address legal barriers to children’s health.

2006

Established a policy team to expand advocacy efforts.

2010

Increased support for Hispanic and Latino families through new partnership. Launched appellate program.

We see the barriers to a child's success.

Despite the notable improvements we've made for children across the District, we continue to see poverty, trauma and racism eroding the all-critical foundation of family, health and education that children need to build their futures:

1 in 4 children live in poverty.

One serious health or education crisis can endanger the financial security of an entire family.

13,000

students have been identified as needing special education services but often receive inadequate supports.

Thousands more are waiting for evaluations and struggling to learn.

16,000 children live with asthma.

A child in Wards 7 or 8 is 20x more likely to end up in the ER for asthma than their wealthier peers, often due to mold, rodents or insect infestations.

60 days

on average pass by until a child in crisis can meet with a psychiatrist.

Each day without help has long-term, harmful effects on a child.



Our Bold Vision

Working directly with more than 5,000 children and families each year gives us a unique vantage point to identify the changing needs of the District's children.

Our current, effective programs seal cracks in the strong foundation children need to thrive. We will continue this important work while **launching new initiatives to prevent these cracks before** they even begin.

We have also seen great success by advocating for changes in the law – and by working with leaders in the community and the government to improve the systems that impact children's lives. But just as a hammer is the right tool for some projects and pliers are needed for others, **there are other legal strategies that we need** at times to get the right results.

Our new areas of work build on what we've learned:

- An engaged parent is the best protection;
- A child's health or educational difficulties can overwhelm families trying to survive in poverty; and
- Racism and other biases can lead to harm.

We also learned the best solutions require collaboration, and – most importantly – there are solutions to even the most complex problems.

Taken together, this transformative work will impact children and their families for generations to come.



Introducing Tenacity & Transformation Our Campaign for DC Children

To make this vision a reality, we are launching our first campaign in our nearly 30-year history to fuel innovative new strategies and ensure we are built to last.



We are looking to you – our donors, institutional funders and corporate partners – to help raise \$10 million from 2025-2027.

With your campaign support, Children’s Law Center will:

Reach more children and families sooner – reducing harm and preventing trauma.

- Represent parents and caregivers when the burdens of poverty are destabilizing, with the long-term outcome of preventing entry into foster care and ensuring children can remain safely at home.
- Embed lawyers in prenatal care teams, family success centers and other neighborhood resources to reach parents before their children’s educational and health issues overwhelm them.
- Work with DC government and community leaders to build the network of supports parents need to provide safe, stable homes for their children.



Add new tools to our toolbox.

- Use impact litigation, class action lawsuits, “state complaints” and other legal tools when necessary to achieve more widespread and lasting results.
- Create a community advocacy team—a network of former clients with the skills to help their neighbors advocate with schools and landlords.
- Leverage federal and local government funding to finance costly renovations of low-income housing to improve health and energy efficiency.
- Disrupt racism and bias through litigation and appellate advocacy and by applying a race equity lens to our policy advocacy.



Ensure our tenacious team has the foundation they need to advocate for DC children and families now and in the future.

- Ensure competitive compensation to recruit and retain the region’s top staff and support their mental health and wellness as they work with families in crisis.
- Optimize new office space with improved technology for virtual court hearings, private rooms for on-site client engagement, and flexible space to support our hybrid workforce.
- Build strong change management practices to respond to an increasingly complex world.
