





VAPA Spring 2018 Meeting recap

Virginia Alliance of Paralegal Associations (VAPA) delegates met on Saturday, March 24, 2018, in Richmond, Virginia. Both of NCAPA's delegates were able to attend this meeting. There were several new delegates in attendance at the meeting from paralegal associations around the Commonwealth, including NCAPA's newest delegate, Charla Beckett.

NCAPA's events (and other associations' events) are being added to the VAPA Event Calendar. As of March 2018, there were 36 Virginia Registered Paralegals. The Virginia Registered Paralegal Program was represented at the Virginia Trial Lawyers Association conference.

Around 70 people from across the nation attended VAPA's first webinar in November 2017. The webinar was free and was entitled, "Are you more ethical than a fourth grader?" The feedback from the surveys was excellent. Another webinar will be offered in the fall.

The main focus of the meeting was to discuss the upcoming education conference. The conference will be held in Fredericksburg, VA on October 5. The registration is \$100 for at least six CLEs with several breakout sessions. NCAPA's delegates and Stephanie Meharg (VAPA President) are working on securing speakers.

The Paralegal's Week Reception will be held from 5:30 to 7:30 at Renato's Restaurant – Back Room, 422 William Street, Fredericksburg, VA 22401.

In the past, VAPA offered scholarships to attend the conference for those who were unable to secure funding from their places of employment. This year, VAPA will be offering one student scholarship and one scholarship for a professional paralegal. These scholarships will cover one night in the hotel (if needed) and the registration fee. Scholarship applications will be worked on and more details provided at the next meeting.

A discussion was held about the possibility of hosting the 2020 conference at James Madison University. There was a suggestion to consider an alternative week to secure the 2020 conference location given the challenge of the first week/weekend in October. Since the conference is held in conjunction with Paralegal Week, which is usually the first week in October, the Board decided as of now that it will remain the first week/weekend in October.

In March, Stephanie Meharg, (VAPA President), Karen Axell, (former VAPA President), and Kathi Ingram met with NCAPA's Board of Directors and VAPA Delegates in Northern Virginia. The purpose of the meeting was to discuss VAPA and the benefits of participation in VAPA as an association. One of Stephanie's goals as President of VAPA is to meet with the associations throughout the Commonwealth.

The next meeting will be held at Markel Corporation in Richmond, VA at 10:30 a.m. on June 23, 2018.



CERTIFICATIONS

Paralegal CORE Competency Exam (PCCE)

The Paralegal CORE Competency Exam (PCCE) was developed to assess the knowledge, skills and ability of early-career and entry-level paralegals. The examination was made available in November of 2011.

Paralegals wishing to sit for the exam should visit the National Federation of Paralegal Associations' (NFPA) website (www.paralegals.org) in order to obtain a PCCE Candidate's Handbook and learn more about the fees associated with the exam. The handbook contains an application, information on exam content, sample exam questions, and logistical information on taking the exam at one of the more than two hundred Sylvan Technology Centers nationwide. Any member interested in applying for NCAPA's PCCE Scholarship should contact the NCAPA Certification Ambassador (certification@ncapa.com).

PCCE is an entry-level exam and paralegals considering sitting for PCCE are encouraged to contact the NCAPA Certification Ambassador for questions, concerns, or suggestions on how to prepare for the exam. Successful strategies for preparing include studying on your own utilizing the PCCE Study Manual, creating/joining a PCCE study group, or taking the on-line American Institute for Paralegal Studies ("AIPS") PCCE Preparation Course.

Once a paralegal has successfully passed PCCE, he or she earns the Core Registered Paralegal (CRP) credential. In order to maintain the CRP credential, paralegals must complete twelve hours of continuing legal education (CLE) credits, including at least one hour in ethics, every two years. It is the individual CRP's responsibility to obtain the necessary CLEs and provide documentation to NFPA in accordance with the renewal guidelines.

Paralegal Advanced Competency Exam (PACE)

In 1992, the NFPA adopted a resolution establishing a position on regulation of the paralegal profession. In 1994, that position was modified to endorse the establishment of the Paralegal Advanced Competen-

cy Exam (PACE). With the assistance of Professional Examination Services, NFPA developed a computer-generated two-hundred question multiple-choice exam designed to be taken within a four-hour time period. Test questions are based on federal law and address topics such as the administration and development of client legal matters, legal research, legal writing, office administration, and ethics.

The purposes of PACE are to provide the groundwork for expanding paralegal roles and responsibilities, to provide the public and legal community with a mechanism to gauge the competency of the experienced paralegal, and to provide a standard for states considering regulation of experienced paralegals.

Paralegals wishing to sit for the exam should visit the NFPA website (www.paralegals.org) in order to obtain a PACE Candidate's Handbook and learn more about the fees associated with the exam. The handbook contains an application, information on exam content, sample exam questions, and logistical information on taking the exam at one of the more than two hundred Sylvan Technology Centers nationwide. Any member interested in applying for a PACE Scholarship should contact the NCAPA Certification Ambassador (certification@ncapa.com).

PACE is not an entry-level exam and paralegals considering sitting for PACE are encouraged to contact the NCAPA Certification Ambassador or other NCAPA RPs with questions, concerns or suggestions on how to prepare for the exam. Successful strategies for preparing include studying on your own utilizing the PACE Study Manual, creating/joining a PACE study group, or taking the seven week on-line AIPS PACE preparation course.

Once a paralegal has successfully passed PACE, he or she earns the Registered Paralegal (RP) Credential. In order to maintain the RP credential, paralegals must complete twelve hours of CLE credits, including at least one hour in ethics, every two years. It is the individual RP's responsibility to obtain the necessary CLEs and provide documentation to NFPA in accordance with the renewal guidelines.

"The increasing threats to attorneys and law firms and the reports of security breaches should dispel this mistaken viewpoint. Significantly, 22% of respondents overall reported that their firm had experienced a data breach at some time—up from 14% last year. Reports of breaches ranged from a high for firms with 10-49 attorneys (35%, more than one-third) to a low of 10% for solos."

I attended a panel discussion at my new company's annual conference held this year on the west coast. The panel was made up of three litigation attorneys and a paralegal. Some wonderful and candid discussions took place in an open Q&A forum but the most revealing insight came when a lead litigation partner at one of the nations largest AMLAW 100 firms stated she assumed her vendors were compliant with the required security. In fact, nothing could be further from the truth. A recent data breach of a major international law firm's emails and confidential ESI happened through their working with a 3rd party vendor.

When your RFP goes out to your vendors, do you require information about security along with pricing and services? Is your vendor of choice HIPAA and PII complaint with current state and federal requirements? Does your vendor maintain the proper backup and current SSAE certification for their data storage facility? If so, what is it and who hosts it? If you're not asking these questions you may be opening you, your client, and your firm to a security night-mare.



Dinner with Generation Z

That, becoming a paralegal does not mean you will instantly or automatically make \$80,000 a year, but that your earnings are achievable based on your work ethic, knowledge level, and by consistently performing exceptionally.

Our dinner with the students was delightful, full of excitement for their future after high school, productive conversation (and probably the best buffalo wings I've ever had), and satisfaction that NCAPA once again exposed the paralegal profession to a the next generation.



Appeals: Not Just for Attorneys

Do you enjoy legal writing? Are you interested in the philosophy of law? Then appeals may be for you!

Appellate work is very different from trial work – appeals involve more legal theory than trial litigation does. As an appellate paralegal, I do not engage in discovery or schedule depositions; rather, I review

and assess a case that has already gone through trial and been ruled on. At trial, a judge determines what the facts are and then applies the relevant law to those facts. If a party appeals the trial judge's ruling, the appellate court then assesses whether the trial judge applied the correct legal standard and evaluates whether the trial judge's decision is supported by the facts in the record. The appellate court reviews the facts the trial judge found for clear error, and if a clear error is found to have affected the ultimate judgment, the appellate court may reverse the trial judge's ruling. The appellate court also determines whether the trial judge abused their discretion in making certain decisions, such as settling procedural disputes, to see if an abuse of that discretion influenced the outcome of the trial.

A paralegal plays a vital role in the appellate process and usually handles the logistical and procedural aspects of appellate practice for the attorneys.

The life of an appellate case is broken up into four main parts: (I) before an appeal is taken; (2) after an appeal is taken but before a brief is due; (3) writing the brief; and (4) after filing the brief but before oral argument. (Each party on appeal generally files one document, called a brief, that sets forth the facts of the case and the legal argument for why the appellate court should affirm or reverse the trial judge's ruling or remand the case for further proceedings.) The paralegal's assignments vary depending on what stage the case is in. Here are some assignments that I do in my capacity as an appellate paralegal:

- I. Before appeal is taken:
 - Attend trial and take notes.
- 2. After appeal is taken but before a brief is due:
 - Order transcripts of the trial.
 - Read the transcripts and prepare transcript summaries for the attorney who will be writing the brief.
- 3. Writing the brief:
 - Proofread for typos, grammar, and style.
 - Cite-check the brief multiple times, making sure all citations comply with appellate court's citations rules and the Bluebook.
 - Compile and redact the appendix that will accompany the brief. (An appendix is a compilation of the trial pleadings to which the brief cites.)
 - Prepare the Table of Contents and Table of Authorities.
 - Electronically file the brief with the court of appeals.
- 4. After filing the brief and before oral argument (if applicable):
 - If the appellate court schedules oral argument for the case, the paralegal arranges moot courts, which involves finding attorneys to act as judges and a time that everyone is available, as well as helping the "judges" prepare for the moot court by telling them about the issues on appeal and sending them the relevant documents they should review).
 - Attend moot courts and record the questions and answers for the arguing attorney to refer back to when preparing for oral argument.
 - Create oral argument binders. There are

usually two binders: one with pleadings, orders, and case law; another with just the trial transcripts.

 Attend oral argument at the court of appeals and debrief with the arguing attorney back at the office.

Of course, an appellate paralegal has a variety of assignments in addition to the work described above. Those tasks include setting up and updating electronic case files, preparing various pleadings for attorneys, conducting legal research and writing memoranda of results, attending case-related strategy meetings, developing and updating training materials, calendaring deadlines and tracking the status of cases, and conducting trainings independently or in conjunction with appellate attorneys.

Success in this area of law requires that a paralegal have a specific skill set. Because a judge's ruling can be overturned on appeal based on one tiny detail, the most important skill for an appellate paralegal to have is intense attention to detail. An appellate paralegal must also have an extensive knowledge of the appellate court's rules and procedures, as each appellate court has its own specific guidelines.

Knowing the rules and procedures governing the logistics of appellate filings, for example, greatly minimizes the likelihood of encountering issues when filing and helps the appellate process move quickly and smoothly.

An appellate paralegal has be confident in their ability to conduct legal research. Arguments made on appeal must be based on solid legal reasoning and supported by legal precedent. A paralegal's ability to provide exceptional cite-checking is a crucial part of this. Correct citations to the record, case law, and statutes, for example, shows the appellate judges that the filing party can be trusted to accurately represent the facts of the case at hand as well as the current status of the relevant law, thus further incentivizing them to do what the filing party asks in their brief.

An appellate paralegal must be able to anticipate the appellate attorneys' needs. One example of this is discerning what the attorney needs to know versus what the paralegal can preemptively handle on their

own. Finally, the paralegal must have excellent oral and written communication skills. As the point-person on the appellate court's rules and procedures and the appellate process in general for the appellate attorneys, an appellate paralegal must be able to efficiently and charismatically communicate facts and ideas.

The appellate process combines detail-oriented tasks with legal theory, which makes being an appellate paralegal very satisfying and provides an opportunity to really make a difference.


